

THIRD PARTY BILLING INFORMATION

Q. WHO IS THE "THIRD PARTY"?

A. You are considered the first party. Forest Hills Emergency Medical Services is the second party. Your insurance company or Medicare is the **Third Party**.

Q. WHAT IS THIRD PARTY BILLING?

A. It is the most common way doctors, hospitals, and ambulance organizations are paid for services rendered to people like yourself. Insurance companies may or may not reimburse for the services provided.

Q. WHAT ARE THE ADVANTAGES OF BEING A SUBSCRIBER?

A. Your subscription membership takes care of 75% of the amount due which your insurance company does not cover, once your deductible is met.

Q. HOW DOES THIRD PARTY BILLING WORK?

A. Every time one of our subscribers uses the ambulance, we will submit a bill directly to the insurance company or Medicare. By obtaining funds this way, we will be able to keep the subscription rate low and still provide the highest quality emergency ambulance service.
